- Please park in designated areas and pick up after your dogs. Do not allow dogs to urinate on buildings, fencing or vegetation around the buildings.

I hereby assume all responsibility and liability for such claims.

I hereby agree to indemnify and hold harmless the United Schutzhund Clubs of America, High Desert Working Dogs [HDWD], its employees, officers, directors, members, guests and property owners and other agents free of any and all claims or claims, including attorney fees, by myself, my family members or any other person accompanying me while on the grounds used for HDWD activities or the surrounding areas thereto as a result of any action by any dog, person or activity including those of myself, my family members or guests.
